Central Depository (Pte) Limited (“**CDP**”) Depositors whose shares are held through CDP will receive their dividends through CDP in Singapore Dollars and will be taxed as a non-resident individual or corporation not engaged in trade or business in the Philippines or 25% thereof, unless documents proving that they are subject to a different tax rate or are tax exempt are provided to the Company.

Stockholders who are availing tax exemption or preferential rate for the Company’s cash dividends, should review the dividend guidelines issued by the Company or through BDO Trust and Investments Group, the Company’s Philippine stock transfer agent. All documents or requirements must be forwarded to the undersigned to enable them to determine the applicable rates and for submission to the Company on or before 2:00 o’clock in the afternoon of May 14, 2024. 
