- (c) Principal Business: The GSIS is a government financial institution which administers the social security benefits of active and retired employees of the Philippine government. It was created by Commonwealth Act No. 186, amended by Presidential Decree No. 1146, and was further amended by Republic Act No. 8291 or the GSIS Act of 1997. It is under the supervision of the Department of Finance (DOF). The main office of GSIS is located at the GSIS Building, Financial Center, Pasay City.

The GSIS is headed by Rodolfo G. del Rosario, Jr. as its Chairman of the Board of Trustees and by Jose Arnulfo A. Veloso as its President and General Manager and Vice Chairman of the Board of Trustees.


